AIRESIS SA ANNOUNCES THE EXTENSION OF THE PUBLICATION DEADLINE FOR ITS 2025 HALF-YEAR REPORT.

Clarens, Switzerland, September 29, 2025 - In its decision of 29 September 2025, SIX Exchange Regulation AG approved the extension of the deadline for the publication of Airesis SA's 2025 half-year report, which had been set for 30 September 2025, until delisting, set on 13 November 2025.

I - The temporary exemption from the publication of the 2025 semi-annual report and to file such report with SIX Exchange Regulation AG until the delisting on 13 November 2025 is granted under the following conditions:

Airesis SA is required to publish a notice in accordance with the provisions on ad hoc publicity concerning this decision until Tuesday, 30 September 2025, 7.30 am CET, at the latest. The notice must contain:

- the unaltered reproduction of the wording of para. I. of this decision, placed in a prominent position;
- the reasons for the application of the Issuer requesting an extension of the deadline to publish its
 2025 semi-annual report and to file such report with SIX Exchange Regulation AG.

This request to SIX Exchange Regulation is made in a context where the company has not yet been able to finalise its 2024 annual report due to delays in the closing of the accounts. As a result, the half year financial statements as of 30 June 2025 cannot be prepared in accordance with regulatory requirements.

By decision of 12 August 2025, SIX Exchange Regulation approved the delisting of Airesis SA shares from the SIX Swiss Exchange. The last day of trading is scheduled for 12 November 2025, and the delisting will take effect on 13 November 2025.
